### **15** Description of Product

The Wolf Mini / Micro Torch Range comprises 5 models using various primary batteries with either a Xenon bulb or LED(s) housed in a straight thermoplastic body. The M-1x, M-2x, M-4x and M-6x may be moulded in static dissipative plastic. The lens end cap retains a transparent plastic lens. The straight body arrangement incorporates a thermoplastic pocket clip and an on/off switch.

The enclosure is sealed dust tight and provides an ingress protection level of IP67.

All the torches are outside the scope of EN 60079-28.

There are five versions which are coded as follows, the second numeral X may vary to denote sub-versions:
